Finally also responsible for the welding department, an organisation of about 40 people. This group produces rail joints using thermitwelding and flashbutt welding. In this job also the initiator together with ProRail for European training of welders.

This was a new role within the VolkerRail Group reporting to the CEO of the VolkerRail Group. Responsibilities included development of new track related products and harmonisation of working methods and implement these within the VolkerRail Group.

During this period also responsible for a large consultancy project for Network Rail: during 6 months working from the head office of Network Rail with an integrated (client and three large European companies) project team and by using System Engineering we found a solution for the renewal of S&C within an 8 hour possession and 25% cost reduction. The findings of this team are being implemented in the UK since 2009.

Also in this timeframe, on special demand of the Board of Directors of VolkerWessels, executed an interim management job in Wales for a Liquid Natural Gas facility.

VR Support was a new, facilitating limited company, supporting the primary operational processes of VolkerRail. The activities of all these limited companies were used throughout the VolkerRail Group. Annual turnover approx 30 million.

Major aspect in this role was the implementation of the philosophy of VSR&T, company rules and attitude in the different Boards, keeping in mind the differences in culture and languages.

Also in the Netherlands responsible for R&D where products such as the mobile workshop, switch heating using geothermal energy, rail noise dampers and the like were developed..

Together with ProRail, BAM and Strukton, we founded an alliance on Track know how, where ideas of the companies in a structured, competitive way were implemented in the railway environment, such as a system for acquiring possessions and the development of video track control.
